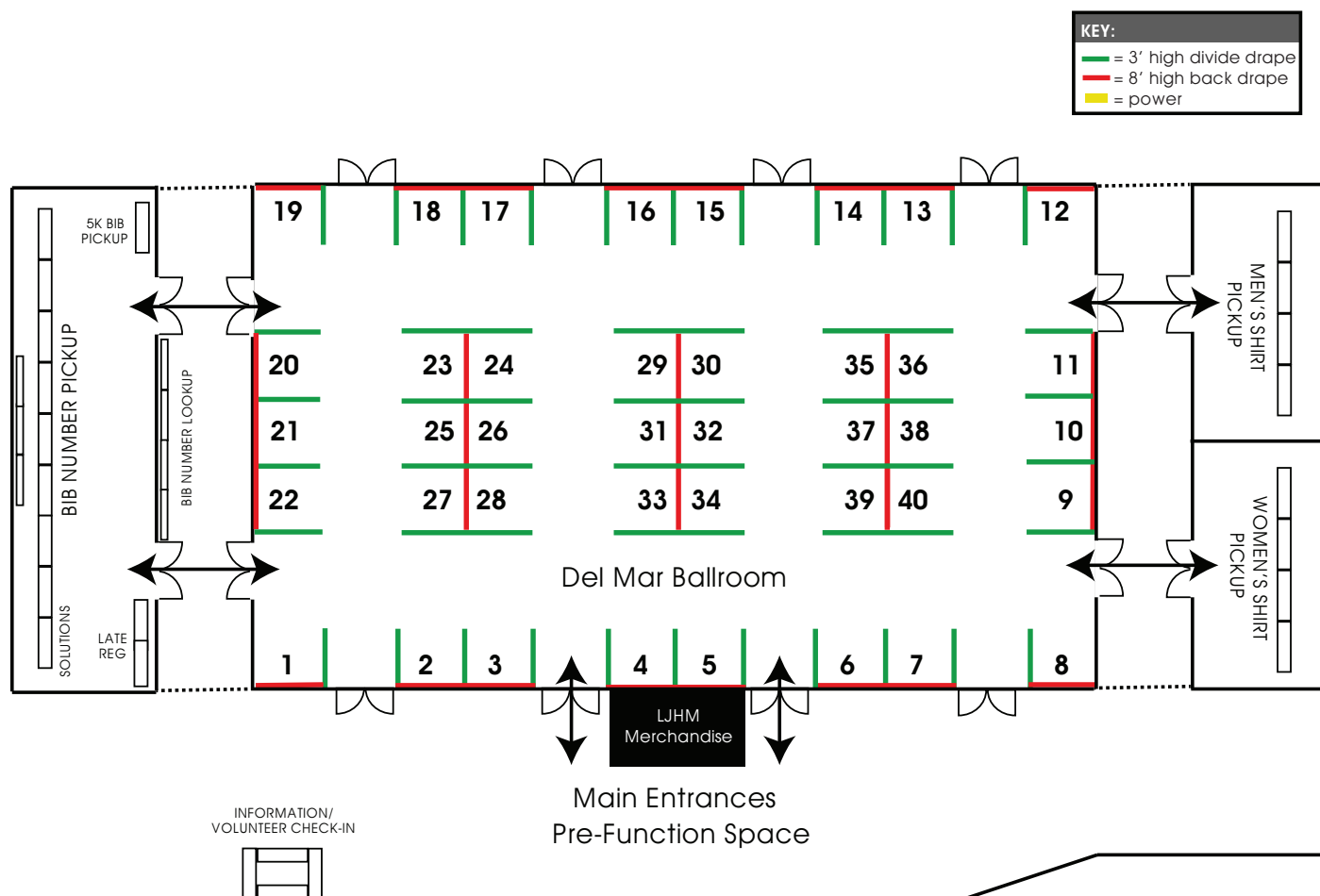

READ AND SIGN BELOW

1. Payment in full is the only guarantee of my booth space(s).
2. If I cancel my purchase in writing and have paid in full on or before March 13, 2018, I will receive a refund of 50% of my full cost. I understand there are no refunds of deposits or partial payments and there will be no refunds issued after March 13, 2018 for any reason including low attendance.
3. I will be billed a \$100 cleaning fee if I or my representatives, upon leaving my booth(s) at the conclusion of the event, leave trash/boxes/debris in my booth(s).
4. Except by written consent of the race management, I cannot sublet or share my booth(s) space with any unauthorized person(s) and/or company(ies).
5. My display must occupy my assigned booth space(s) only and not encroach into the aisles or other booths. Leafleting anywhere outside of my designated booth space(s) is not permitted.
6. I must occupy the booth(s) assigned to me. No booth(s) changes will be made on site.
7. I grant the rights to use photographs of the event to the La Jolla Half Marathon for its own purposes.
8. I must staff my booth(s) continuously during the listed event hours.
9. Vendors handling or selling any type of food product (including pre-packaged foods and energy bars) are required to have a City of San Diego health permit or temporary food facility permit. New permits must be obtained no less than 14 days prior to the event date. For more information call 858.505.6809.
10. All materials in my booth(s) must meet San Diego Fire Department regulations, including but not limited to fire retardant banners and canopies (must have fire-retardant certification seal) and no open flames are permitted.
11. The La Jolla Half Marathon reserves the right to refuse this application for any reason whatsoever.
12. In the event that, due to war, fire, strike, government regulation, public catastrophe, severe weather, or other cause, the event or any part thereof is prevented from being held, the La Jolla Half Marathon shall determine to refund the proportionate share of unused funds, or offer free booth(s) space at the next La Jolla Half Marathon and either will not be subject to challenge.
